DURING THE DISTRIBUTION, WE PROVIDE EDUCATION & INFORMATION ON TOPICS AND OPPORTUNITIES TO HELP IMPROVE HEALTH & WELL-BEING AS WELL AS SELF-SUFFICIENCY.
